- A *non-refundable fee* of \$25 (twenty-five dollars) must be submitted with this application.
- Application requirements - all applicants must submit a 2 to 4 minute, non-commercial “YouTube” video clip of the entity proposed to minister during the Holy Convocation Thursday, November 5 – 10:30 p.m.

- Artists, or representative, will receive a confirmation email within seven (7) business days after email has been received. If you are confirmed, you will receive a “Ministry Agreement.” Once completed and signed, you must send your presentation submission payment as specified below.

### IV. ENTRY FEE(S)

**CHECK THE APPLICABLE CATEGORY:** The presentation submission fee for either **Category A** or **B** should only be submitted once notification that your Jurisdictional Choir has been selected to minister. The presentation fee will be waived for those jurisdictions that have paid their jurisdictional reports in full.

## V. PRESENTATION GUIDELINES AND MINISTRY REQUIREMENTS

The Holy Convocation for the Church of God in Christ represents our high holy gathering of Saints. The IMD, with the help of God, does its' best in presenting the level of spirituality, on both a natural and musical level, for which our Church is known and respected. Pursuant to this, the choirs and artists whom we have solicited to join us in this high holy gathering of Saints are asked to assist us in maintaining this level, by governing themselves in a manner which bespeaks Holiness. The Artist is responsible for managing behaviors of Artist entourage, backstage and elsewhere in or around the venue and at the lodging facility. To maintain this level of holiness, we request the following.

- Presentation must be done within a limit of **5 minutes**.
- Lyrics must be theologically and biblically sound, and communicate the truths of God.
- Song must be centered on and focused toward God's approval, not man's entertainment.
- Ministry Attire:  
Ladies—No slacks, tight skirts, jeans, capris, shorts, mini dresses or clothing which is revealing in nature.  
Men—All braided hair or dreads, should be tied back and off of face. No earrings, tight or sagging pants allowed.
