³ The Flint Water Crisis is a drinking water contamination crisis in Flint, Michigan that started in April, 2014 when the state decided to save money by switching Flint's water
4 supply from Lake Huron to the Flint River, a notorious tributary that runs through town. The Flint River is known to locals for its filth.

The switch was made during a financial state of emergency and was supposed to be temporary while a new state-run supply line to Lake Huron was ready for connec-tion. The project was estimated to take about two years. After the change, the city's drinking water
had a series of problems that culminated with lead contamination, creating a serious public health danger.

Churches from bordering states were asked to commit to acquiring varying sizes of UHaul trucks filled with water, ready made Similac, and Enfamil.

B Pastors from far reaching areas also participated by providing monetary donations. Flint Michigan clergy, city officials, community organizers all participated in this humanitarian effort; Bishop Roger L. Jones, Special Assistant to Mayor Weaver. A.C. Dumas, Charles M. Hughes, and Charlotte Keels. Pastor Philemon Reed of Reed Temple COGIC met the representatives of Christ Community COGIC in Ben-ton Harbor Michigan and took their trailer on to Flint. Without you, this contribution would not have been possible.

Church Of God In Christ, Inc. General Council of Pastors and Elders Proposed Election Protocol For Jurisdictional Pastors and Elders Council Staff Resolution #042016-3

Whereas, the Jurisdictional Council of Pastors and Elders (JCPE) plays a significant role in the life of the Jurisdiction as part of the ecclesiastical structure and operates as a lower trial court

Whereas, in 1993, a resolution was issued in the General Assembly authoriszing the creation of JCPE in every ecclesiastical jurisdiction

And whereas, in April 2013, an amended resolution was issued in the General Assembly requiring all jurisdictions to have in operations a JCPE, whereby the officers of the council are elected by the ordained elders in that jurisdiciton

Whereas, many have implemented the JCPE as required, others have not and are requesting a standard process for instituting the JCPE and maintaining the integrity of the process

Whereas, the General Assembly adopted and approved the establishment of a JCPE in every jurisdiction

Whereas, the General Council of Pastors and Elders has documented the following process as the standard operating policy and procedures for establishing the Election Process for the Jurisdictional Council of Pastors and Elders which is outlined below:

Nomination/Election Committee

1. The Bishop selects an Election Commissioner who in turn selects the Nomination/Election Committee (3-5 committee members including the Commissioner) from men, whom are not running for any Jurisdictional Council of Pastors and Elders (JCPE) office, 2. The Election Commissioner presides over the Nomination and Election process.

- 3. Once the election is completed the Election Commissioner and Nomination/Election Committee roles cease.
- 4. The newly elected officers will conduct the business of the Jurisdictional Council of Pastors and Elders (JCPE) going forward.

Nominee Qualifications

- The candidate should be in good standings with the National Church and the Jurisdiction. Have a current valid credential holder card.
- Any candidate running for position in the Jurisdiction should also complete the sexual misconduct training and submit to a background check as prescribed by the National Church.
- Upon their election in the Jurisdiction and confirmation that they have met the national standards, the proper certificates will be released from the office of the General Secretary.

Nominee Questionnaires

Every nominee must submit the appropriate nominee questionnaire in order to run for a position. Each year the Jurisdictional Nomination/Election Committee shall compose a questionnaire for each position designed to elicit details of each nominee's relevant experience.

- 6)Describe any concerns or limitations on your ability to serve the entirety of a four year term.

Close of Nominations

The nomination period closes approximately five (5) calendar days prior to the election. If the close of nominations would occur on a weekend, the nomination period is extended until the first following business day.

Finalizing Candidates

- The Nominartion/Election Committee reviews all completed nominations to verify that the above process was followed and reviews the nominee questionnaires to determine that all nominees meet the general criteria.
- The minimum number of qualified candidates must total the number of seats up for each election; otherwise the nominees whom are prepared will proceed with the election. The remaining seat, the nomination period will be reopened and another review held by the Nomination/Election Committee.

Pastors and Elders Notificaton of Final Slate of Candidates

The Nomination/Election Committee will send the final slate of candidates along with their biological information, via email to all Pastors and Elders of said Jurisdiction.

All candidates shall be given the opportunity to presen themselves to the general membership in a brief speech on Election Day.

<u>Quorum</u>

A quorum is the total voters present and voting on Election Day.

<u>Voting</u>

In order to vote during the election, a Pastor's or Elder's credential must be in good standings.

Voting Counting and Results

The Nomination/Election Committee shall tally the votes to determine the winner. If requested by a candidate for election, they shall provide these individuals with poll watchers and an opportunity to view a copy of the voting log from the election.

<u>Tiebreak</u>

If the candidates have not received 50% +1 of votes for the available seat, the two candidates with the most votes, will be placed on a ballot for a run-off to select a winner. The Nomination/Election Committee will confirm the winner of the tiebreak election, who shall be declared to have won the election. In the event any tiebreaker which does not meet the 50% +1 must have a run-off to determine the final two candidates for election.

<u>Term of Office</u>

- The term of the office of the elected candidates will be four years
- *The election will convene during the year of the National Quadrennial election of officers.

Therefore, be it resolved that the General Assembly adopts and approves the General Council of Pastors and Elders documented process as the Standard Operating Policy and Procedures for Establishing the Jurisdictional Council of Pastors and Elders Election Protocol.

After Nine Years, Harvest Homes Breaks Ground



Members of its staff worked hard to restructure the project's funding, help find consultants, and serve as a resource for PCDAC's needs. CCLF issued a loan of approximately \$356,000 for PCDAC for the 36-unit apart-

ment community that will now offer affordable housing. Harvest Homes' Groundbreaking Ceremony in mid-July was a long awaited celebration of the development. Reverend Eaddy was joined by many of Chicago's leaders including Mayor Rahm Emanuel, Congressman Danny Davis, Congressman Bobby Rush, CCLF's President Calvin L. Holmes, and others. HARVEST HOMES is under construction

In 2006 Reverend Michael Eaddy, the Executive Director of the People's Community Development Association of Chicago, Inc. (PCDAC), reached out to the Chicago Community Loan Fund (CCLF) for a loan. It was to be used for the pre-development of Harvest Homes, a 36-unit affordable housing project in East Garfield Park. After receiving approval, however, PCDAC encountered a series of road blocks that stalled the advancement of the project.

When logistical issues combined with the recession's harmful effects on the real estate market, the completion of Harvest homes was put in jeopardy. Fortunately CCLF (with help from the NHP Foundation) put its flexible financing and technical assistance into action.



months, Harvest Homes' story is certainly out of the ordinary. CCLF staff, however, have been committed to moving the project through and are very pleased to see it continue onto its next stage after nearly a decade. It is part of CCLF's mission to offer a comprehensive hands-on assistance to borrowers, especially when they are experiencing unusual delays in their projects. This patience sets CCLF apart from other lenders and makes us a great resource for smaller, emerging borrowers.
