Scholarships are open to all high school graduates that will be attending a college/university **full-time** in the fall, as well as those who are already enrolled and attending full-time in an accredited college/university, pursuing an undergraduate degree. **Without exception, graduate degree students must be taking a minimum of 9 credit hours. PLEASE BE SURE YOUR NAME IS ON ALL PAGES.** Recipients will be required to submit final grades for the 2019 fall semester **BEFORE** checks are released. **DEADLINE FOR SUBMISSION OF GRADES IS January 31, 2020, NO EXCEPTIONS.**

Applicants may apply each year if a minimum 2.5 GPA is maintained. Applicants are selected based on exemplary traits including leadership, community involvement, academic excellence and responses to the essay questions. The information provided on the scholarship application, including essays and letters of recommendation will be used in determination of the scholarship awards.

Review and evaluation of all applications will be done by the COGIC Charities Scholarship Review Committee. Recipients will be notified in late October via email. Please be sure to include your correct email address and phone number.

Verification of financial information and request for official transcripts will be made if applicant is selected. Once selected, freshmen students must submit an official transcript of their first semester grades, which are sealed. College students must have the college/university send an official transcript to: **Ms. Sylvia Law, Chair COGIC Charities Scholarship Committee. (See the address above.)**

After the selection process has been completed, and the grades for the fall semester have been received, the Scholarship checks will be made payable to the college/university and will be mailed directly to the college/university. Copies of all scholarship communiqué will be sent to the applicant. No checks will be sent to the recipient.

Should the recipient fail to enroll, or drop below full-time status, or withdraw from the college/university during the period covering the award, the recipient and/or institution **must return all funds associated with the award**. Applicant who does not comply with all the above stipulations will forfeit this scholarship award.

Scholarship Awards will be made in November of each year at the annual COGIC Charities banquet. The banquet is held during the Church of God in Christ Holy Convocation. (See the COGIC.org website for date of the banquet). The ticket cost for the banquet is \$200.00. Scholarship recipients are encouraged to attend the COGIC Charities Scholarship banquet. However, one does not have to attend the banquet to receive an award.

COGIC Charities Scholarship Questions 2019-20

1. In 2010, law professor, Michelle Alexander, published *The New Jim Crow: Mass Incarceration in the Age of Colorblindness*. The author shows the correlation among African American slavery, the prison industrial complex and present-day mass incarceration of African American men. The book has resulted in many shifts in the public policy discussions on criminal justice. Later, in his 2017 book, *Locking Up Our Own: Crime and Punishment in Black America*, James Forman, Jr. argues that the leadership in Black America was partially responsible for the rapid increase in black incarceration rates in America. He further asserts that African American leaders demanded that local, state and federal governments participate in attempts to stop crime in black neighborhoods, much of which had resulted from drug sale and usage. Reflecting on what crime has done to many African American neighborhoods, and what mass incarceration of black men has meant to many black families, write a two or three paragraph essay on the mass incarceration of African Americans in 2019.

2. On November 27, 2018, Missionary John A. Chau was killed by some Sentinelese, an indigenous group, who live on North Sentinel Island just off the coast of India. For thousands of years, these ancient people have lived isolated from other societies. They refuse to accept modern life and maintain a hunter-gathering life style. They have always defended their island territory and fighting off visitors with bows and poison arrows. Even though, according to Indian law, it was illegal for to enter Sentinelese territory, it had been Mr. Chau's goal to bring the gospel of Jesus Christ to this hostile group. Thus, failing to heed warnings and knowing that the Sentinelese had long resisted the intrusion of outsiders, the 26-year-old missionary from Washington State persisted in going to the Island to reach this group for Christ. Ultimately, like others before him, he was killed. Based on Missionary Chau's case, please answer the following short answer questions.
 - a. Is there any benefit to the Kingdom of God and the saving of sinners when one dies in a situation like Missionary John A. Chau? If so, describe and explain those benefits. If not, explain why his actions were not beneficial.
 - b. Is there a difference between "faith" and "being unwise?" If so, please explain the difference in the context of Missionary Chau's story. If not, please explain why there is no difference.
 - c. In Missionary Chau's decision to approach the ethnic group on North Sentinel Island, he decided to break the law. The scripture has admonished believers to obey the laws of the land. Is it ever "right" to break the law in order to do a "work for the Lord?" If so, when?

3. On November 26, 2018, the Associated Press reported that Dr. He Jiankui, a Chinese scientist in Shenzhen, China, claimed to have successfully produced the first genetically-altered babies. Dr. Jiankui's laboratory took a single embryo, edited the DNA, and produced twin girls. There were ethical issues associated with the procedure. There was much criticism in the scientific, religious, and educational community. In order to defend his experiment, Dr. Jiankui stated that the children's father is HIV positive, and that the two genetically-altered babies are now healthy. The doctor posted an on-line video to justify and explain the procedure. He also stated that by altering the genes, the procedure would reduce the twins' risk of also getting the HIV infection. However, these modifications can have lasting effects. DNA changes can be passed to future generations; moreover, it is possible that they can also harm other genes. Based on Dr. Jiankui's claims, answer the following questions:
 - (a) Do you believe it is appropriate for scientists to modify the genetic makeup of human beings? Please cite a relevant scripture to support your conclusion.
 - (b) If the genetic editing that is described in the precis will serve to create humans who are not susceptible to contracting HIV, how can such editing be problematic? Please explain.
 - (c) In this time of scientific advancement, when they seem to be at odds, explain how one works to reconcile faith and science.
